In accordance with Chapter 39.34 RCW, King County and the Chelan-Douglas Public Transportation Benefit Area (dba Link Transit) agree to a cooperative governmental purchasing agreement for various equipment and supplies using King County's competitively awarded contracts.

King County therefore extends the use of its contracts to Link Transit to the extent provided by law and upon the following terms:

- (1) The vendor(s) agree to extend to Link Transit the terms and conditions of King County's contract(s).
- (2) Link Transit accepts responsibility for compliance with any additional or varying laws and regulations governing its purchases. Any purchases by Link Transit shall be effected by a purchase order from Link Transit and directed to the vendor.
- (3) King County accepts no responsibility for the performance of any of the purchasing contracts by the vendor.
- (4) King County accepts no responsibility for payment of the purchase price by Link Transit.

This agreement may be revoked at any time in writing by either party.
